**ORDINANCE NO. 2009- \_\_\_\_\_**

AN ORDINANCE TO ESTABLISH SPEED LIMITS ON CERTAIN ROADS IN  
THE TOWN OF SCHLESWIG

**WHEREAS**, The Town Board of the Town of Schleswig, Manitowoc County, Wisconsin finds that, based on investigation, the statutory speed limit on certain Roads in the Town of Schleswig, as further defined in this ordinance, is greater than is reasonable or safe under the conditions found to exist; and

**WHEREAS**, The Town Board declares the necessity to establish a reasonable and safe speed on said Roads different from that established by Wisconsin Statute;

**NOW, THEREFORE**, The Town Board of the Town of Schleswig, Manitowoc County, Wisconsin, pursuant to its authority under Section 349.11, Wis. Stat., in order to promote public safety and welfare, do ordain as follows:

SECTION 1, SPEED RESTRICTION. The speed restriction for the following Roads located in the Town of Schleswig, Manitowoc County, WI shall be forty five (45) miles per hour:

- (1) Lax Chapel Rd between County Highways X and XX
- (2) Rockville Rd between Lax Chapel Rd and Louis Corners Rd

The speed restriction for the following Roads located in the Town of Schleswig, Manitowoc County, WI shall be thirty five (35) miles per hour:

- (1) Lax Chapel Rd north of County Hwy X ahead of addresses between 11807 and 11415 Lax Chapel Rd
- (2) Lax Chapel Rd from State Hwys 32/57 south to the Manitowoc/ Sheboygan County Line
- (3) Rockville Rd from State Hwy 67 east to Lax Chapel Rd
- (4) Meggers Rd from Fish and Game Rd south to the Kiel City Limit
- (5) Cemetery Rd between State Hwys 32/57 and Rockville Rd
- (6) Steinthal Rd between Rockville Rd and County Hwy XX

SECTION 2. SIGNS. The Town Chairperson or his designee is authorized and directed to install official signs necessary to effectuate the terms of this ordinance. Such signs shall be in conformity with the Uniform Traffic Sign Manual, the Wisconsin Administrative Code, and all other rules and regulations.

SECTION 3. SEVERABILITY. The provisions of this ordinance are severable. In the event any portion of this ordinance is determined to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such determination shall not affect the remainder of this ordinance. The Town Board hereby declares its intent to have passed all other provisions of this ordinance and the remainder of the ordinance shall not be affected by such determination.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after September 1, 2009.
