ORDINANCE NO. 2012 - /

**AN ORDINANCE TO REGULATE AND PROHIBIT PARKING OF VEHICLES
WITHIN THE TOWN OF SCHLESWIG
(CEDAR LAKE AND WILKE LAKE AREA)**

The Town Board of the Town of Schleswig, pursuant to its village powers and pursuant to Sections 349.13 and 346.55, Wis. Stats., in order to provide for the welfare and safety of the residents of the Town of Schleswig, and in the interest of public safety and health, do ordain as follows:

SECTION 1. DEFINITIONS. For the purposes of this Ordinance:

- (a) "Operator" means a person who drives or who is in the actual physical control of a vehicle.
- (b) "Park" or "parking" means the halting of a vehicle, whether occupied or not, except temporarily for the purpose of and while actually engaged in loading or unloading property or passengers.
- (c) "Vehicle" means every device in, upon or by which any person or property is or may be transported or drawn upon a highway, except railroad trains.

SECTION 2. PARKING PROHIBITED. It shall be unlawful for any person to park a vehicle within the following described areas in the Town of Schleswig, Manitowoc County, Wisconsin, at any time.

- (a) Henning Road -- Both sides of road
- (b) Louis Corners Road -- Both sides of road from Rockville Road to Woodside Lane.

(c) Rockville Road – Both sides of road from South Cedar Lake Road to Louis Corners Road.

(d) South Cedar Lake Road – Both sides of road from Rockville Road to West Washington Road.

(e) Split Rail Lane – Both sides of road

(f) Squire Lane – Both sides of road

(g) Wilke Lake Road – Both sides of road from intersection with Point Creek Road north to the Wilke Lake boat landing.

SECTION 3. REMOVAL OF VEHICLE. Any vehicle parked in violation of this Ordinance may be removed and towed by the Town Constable, Manitowoc County Sheriff's Department, or the designee of either. Traffic control signs indicating such Tow-Away Zone shall be erected according to Section 6 of this Ordinance. The cost of such removal shall be the responsibility of the operator, owner, or person who claims said vehicle.

SECTION 4. PENALTIES. The penalty for violating any provision of this Ordinance shall be \$100.00, together with the costs of prosecution according to law. The Town Constable or his designee or the Municipal Judge of the Municipal Court which includes the Town of Schleswig is hereby vested with authority to receive payment of those penalties and issue a receipt therefor. All such payments shall be deposited with the Clerk of the Municipal Court which includes the Town of Schleswig, or if none, with the Town of Schleswig Treasurer.

SECTION 5. ENFORCEMENT. The Town of Schleswig Town Constable and the Manitowoc County Sheriff's Department are each separately empowered to enforce the provisions of this Ordinance and to issue citations for violations hereof. In addition, the Town Chairman, any Town Supervisor, and a Town Board designated Commissioner of the Town of

Schleswig Sanitary District No. 1 are each separately empowered to enforce the provisions of this Ordinance and to issue citations for violations hereof. Each is further authorized and empowered to enforce any restrictions or prohibitions of parking adopted by Manitowoc County pertaining to the Cedar Lake and Wilke Lake Boat Landing areas owned by Manitowoc County. Said restrictions and prohibitions of parking adopted by Manitowoc County are incorporated herein by reference.

SECTION 6. TRAFFIC CONTROL SIGNS. The prohibitions contained herein shall be effective upon adoption of this Ordinance and upon official traffic control signs being placed or erected indicating the prohibition and limitations set forth herein.

SECTION 7. SEVERABILITY. The provisions of this Ordinance are severable. If any portion hereof is found to be void or unenforceable by a court of competent jurisdiction, the remaining portions hereof shall remain in full force and effect.
